Owner also releases and agrees to indemnify and hold Laredo Petroleum, Inc. harmless for any loss, claim, damage or interest incurred as the result of Owner's depository institution's failure to properly or promptly post any ACH payment and/or as a result of any error or omission in the payment instructions provided by or on behalf of Owner. Owner understands and agrees that Laredo Petroleum, Inc. will have up to sixty (60) days after receipt of the authorization form to process the ACH request.

Confirm that your bank accepts deposits made electronically and provide a copy of a voided check to that account.

If you are not the Owner/Payee, you must provide documentation that authorizes you to act on behalf of the Owner/Payee for financial transactions.
